<b>What is the overall <u>deductible</u>?</b>	In- <u>Network</u> : EE Only \$1,600; EE+ Family \$3,200. Out-of-Network: EE Only \$3,200; EE+ Family \$6,400.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. The family <u>deductible</u> is a cumulative <u>deductible</u> for all family members. The overall family <u>deductible</u> must be met by one family member or a combination of family members before the plan begins to pay.
<b>Are there services covered before you meet your <u>deductible</u>?</b>	Yes. In- <u>network</u> <u>preventive care</u> is covered before you meet your <u>deductible</u> .	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. The <u>out-of-pocket limit</u> is the most you could pay in a year for covered services. The family <u>out-of-pocket limit</u> is a cumulative <u>out-of-pocket limit</u> for all family members. **Does this plan provide Minimum Essential Coverage? Yes.**

If you are eligible for certain types of Minimum Essential Coverage, you may not be eligible for the premium tax credit.
